### NOTIFICATION

In exercise of the powers conferred by the proviso to Section 8 of the Goa, Daman and Diu Sales Tax Act, 1964 ( Act 4 of 1964) applicable to this Union Territory of Daman and Diu, the Administrator of Union Territory of Daman and Diu hereby specifies the first point of sale as the point at which the following goods shall be taxed.

- I Plastic Granules, Plastic Chips/Liquid or powder including PVC, LDPE, HDPE, PE, Polypropylene, LLDPE, nylon, Polystyrene, Polycarbonate, ABS, SAN, EVA and Industrial Plastics
- II P.O. Yarn, P.F. Yarn, Nylon Yarn and all type of synthetics and Polyester Yarn used as raw material in manufacturing.
- III Master Batches and Fillers, Plastic Stabilizers, Colors & Pigments
- IV Kraft paper & boards, Duplex paper and board, Glaze paper, Butter paper and all other type of paper except News print.



- V. Phthalic Anhydride, Maleic Anhydride, Nonal Butanol, Iso Butanol, 2-Ethyl Hekanol, 2-Ethyl Hekanol-Light, Iso Octanol, Iso Decanol, Methanol, Ethyl Alcohol, Acetic Acid, Para Toluene Sulphonic Acid, Sulphuric Acid, Butyl Titrate Monomer, Caustic Soda, Soda Ash, Activated Carbon, Stearic Acid, Castor Oil, Soya Oil, Butyl Stearate, Benzyl Acetate, Adipic Acid, Iso Non Alcohol, Calcium Carbonate, Titanium Dioxide of all type, China clay, Toluene, Acetate, all type of acetone, Propylene, Glycol, Xylene, Silicone Aresal, Perfumery Chemicals, High Normal perrain, phenol.
- VI. Antistatic oil and coning oil.
- VII. Oleo pine resin, gum resin and turpentine oil.
- VIII. Ingots, slabs, Billets, Bars, Rounds, Rod, Wire rods, Wires(rolled & drawn), Strips, sections, sheets, tubes, foils ( in coiled or straight form), plates castings, scrap, residue, defectives, cuttings, end pieces, Dross Ash Runners & Risers, Dust of Zinc, Brass, Copper, Aluminum and Lead

Provided that in respect of the above mentioned goods lying in stock with any registered dealer on the date of coming into force of this notification, the first sale of such goods in stock shall be the point at which the tax shall be levied.

NOTIFICATION

In exercise of the powers conferred by Sub-Section(1) of the Section 10A of the Goa, Daman and Diu Sales Tax Act, 1964 ( Act 4 of 1964) applicable to this Union Territory of Daman and Diu, the Administrator of Union Territory of Daman and Diu having considered it necessary to do so in the public interest hereby exempt the sales of following goods from the tax payable therein under clause (c) of Sub-Section(1) of Section 7 of the Act to the extent of five paise in the rupee.

NOTIFICATION

In exercise of the powers conferred by Sub-Section(1) of the Section 10A of the Goa, Daman and Diu Sales Tax Act, 1964 ( Act 4 of 1964) applicable to this Union Territories of Daman and Diu, the Administrator of UT of Daman and Diu having considered it necessary to do so in the public interest hereby exempt the sales of "Iron and Steel" ( with the same meaning as it is attributed to these items by Section 14 of the Central Sales Tax Act, 1956, as amended from time to time) from the tax payable therein under clause (b) of Sub-Section (1) of Section 7 of the Act, to the extent of three paise in the rupee.

This is issued in supersession to the earlier Notifications in respect of entry 'Iron and Steel'
