NOTIFICATION

In exercise of the powers conferred by the proviso to Section 8 of the Daman and Diu Sales Tax Act, 1964 (No.2 of 1964), as applicable to this Union Territory of Daman and Diu, the Administrator of the Union Territory of Daman & Diu hereby specifies the first point of sale as the point at which the following goods shall be taxed.

1. Bulk drugs (Entry No.7 of the First Schedule)
2. Edible oils and oil cake (Entry No.14 of the First Schedule)
3. Ice (Entry No.18 of the First Schedule)

4. All goods required by a dealer as raw materials for the purpose of manufacturing (as specified in his Certificate of Registration) including Industrial Inputs, Non-Ferrous Metal, viz., Sulphur, Zinc and Aluminium, Belting, Bearing, Chemicals such as Barytes, Hydrogen Peroxide, Silicon Carbide, Lime Caustic Soda and Ferro Silicon, Dyes, Ferro-Alloy and Super-Alloy, Refractory Bricks, Transformer, Polystyrene (Entry No.19 of the First Schedule)
5. Kerosene other than PDS Kerosene (Entry No.20 of the First Schedule)
6. Vanaspati (Entry No.35 of the First Schedule)
7. Vegetable Oil (Entry No.36 of the First Schedule)
8. Iron and steel as defined under Section 14 of the Central Sates Tax Act, 1956 (Part of Entry No.12 of the First Schedule)
9. Building Materials such as wood, bamboo and plywood including Cement (Entry No.6 of Second Schedule)
10. Drugs and Medicines other life saving drugs and bulk drugs (Entry No. 14 of the Second Schedule)
11. Milk Food and Milk Products (Entry No.28 of the Second Schedule)
12. Tea and Coffee (Entry No.46 of the Second Schedule)
13. Tyres and Tubes (Entry No. 51 of the Second Schedule)
14. All the goods included in the Third Schedule.
15. All the goods included in the Fourth Schedule.

Provided that in respect of the above mentioned goods lying in stock with any registered dealer on the date of coming into force of this Notification, the first sale of such goods in stock shall be the point at which the tax shall be levied.

This Notification shall come into force from the date of publication in the Official Gazette.
