NOTIFICATION

In exercise of the powers conferred by the proviso to Section 8 of the Daman and Diu Sales Tax Act, 1964 (No.2 of 1964) hereby specifies the first point of sale as the point at which the following goods shall be taxed:-

1. Fishing nets.
2. Fishing twine, ropes, floats and other fishing equipments other than mechanised boats and vehicles.

Provided that in respect of the above mentioned goods lying in stock with any registered dealer on the date of coming into force of this Notification, the first sale of such goods in stock shall be the point at which the tax shall be levied.

This Notification shall come into force from the date of publication in the Official Gazette.
