### NOTIFICATION

In exercise of the powers conferred by the proviso to Section 8 of the Daman and Diu Sales Tax Act, 1964 (No. 2 of 1964), the Administrator of the Union Territory of Daman & Diu hereby specifies the first point of sale as the point at which the following goods shall be taxed.

1. "All goods required by a dealer for use in packing of goods for sale/re-sale (containers and other packing materials) specified in his Certificate of Registration."

Provided that in respect of the above mentioned goods lying in stock with any registered dealer on the date of coming into force of this Notification, the first sale of such goods in stock shall be the point at which the tax shall be levied.

This Notification shall come into force from the date of publication in the Official Gazette.
