दमण एवं दीव मोटर वाहन नियमावली, 1989 में निम्नलिखित संशोधन किये जाने का प्रस्ताव है, जिसे मोटर वाहन अधिनियम, 1988 (वर्ष 1994 का केन्द्रीय अधिनियम सं. 54) की धारा -212 की उप-धारा (1) की अपेक्षा के अनुसार इससे प्रभावित होनेवाली जनता के सूचनार्थ प्रकाशित किया जाता है तथा एतद्वारा यह नोटिस भी दी जाती है कि यह अधिसूचना सरकारी राजपत्र में प्रकाशित होने की तिथि से 15 दिनों के बाद सरकार द्वारा उक्त मसौदा संशोधन पर विचार किया जाएगा।

यह अधिसूचना सरकारी राजपत्र में प्रकाशित होन की तिथि से 15 दिनों की समाप्ति से पहले उक्त मसौदा संशोधन पर की जाने वाली आपत्तियों एवं सुझाव उप-सचिव (परिवहन), कार्मिक विभाग, सचिवालय, गोटी दमण को प्रेषित किए जा सकते हैं।

मसौदा संशोधन

दमण एवं दीव मोटर वाहन नियमावली, 1989 में आगे संशोधन हेतु अधिसूचना।

मोटर वाहन नियमावली, 1988 (वर्ष, 1988 का केन्द्रीय अधिनियम-59) की धारा-28, 38 एवं 65 तथा वर्ष, 1994 के यथा संशोधित अधिनियम सं.-54 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए प्रशासक, दमण एवं दीव एतद्वारा दमण एवं दीव मोटर वाहन नियमावली, 1989 में निम्नलिखित संशोधन करते हैं।

इन नियमों को दमण एवं दीव मोटर वाहन (संशोधन) नियमावली, 2003 कहा जाएगा।
ये तत्काल लागू होंगे।

3. नियम-3 में संशोधन
संबन्धित नियम-3 के बदले निम्नलिखित नया उपबन्ध प्रतिस्थापित किया जाएगा।
“दमण एवं दीव जिलों के लिए लाइसेंस प्राधिकारी का पद धारण करने के लिए प्रशासक द्वारा नियुक्त कोई अधिकारी होगा” ।
4. नियम-42 में संशोधन
संबन्धित नियम-42 के बदले निम्नलिखित नया उपबन्ध द्वारा प्रतिस्थापित किया जाएगा :-
“दमण एवं दीव जिलों के लिए पंजीकरण प्राधिकारी का पद धारण करने करने के लिए प्रशासक द्वारा नियुक्त कोई अधिकारी होगा” ।
