### NOTIFICATION

In exercise of the powers conferred by Sub-Section (1) of Section 103 of the Daman and Diu Value Added Tax Regulation, 2005 (1 of 2005) (hereinafter referred to as the said Regulation), the Government hereby otherwise amends the First Schedule to the said Regulation in the following manner, namely :-

**(A) Amendments in the First Schedule appended to the said Regulation :**

1. After entry no. 38 in the 1st Schedule, the following entry no. 39 shall be substituted, namely :-

39. "Liquor (Foreign and Indian made Foreign Liquor) and Country Liquor sold by the Canteen Stores Department or by the Unit Run canteens to the retired and service personnel of Armed forces" subject to following conditions -

*Explanation.-* For the purpose of this clause, the expression "Members of the Armed Forces" shall include ex-service personnel and war-widows identified as such by the Ministry of Defence / Army, Navy and Air Headquarters or their subordinate / attached offices.

This notification shall come into force with immediate effect.
